



GENERAL RENTAL GUIDELINES

- All rentals are subject to a minimum of \$200.00 cancellation fee.
- All rental spaces have a 4 hour minimum requirement.
- Fieldhouse Rentals requiring Floor Covering will be charge an additional \$500/Per Gym Block.
- Rentals must be paid in full two weeks prior to.
- Tables and chairs are provided at rental facilities, Fieldhouse rentals will have to rent appropriate chairs if more than 600 chairs are needed.
- Floor plans need to be turned in two weeks prior to event to insure proper set up.
- Smoking is strictly prohibited in all City facilities or in any other public areas in accordance with the Florida Clean Air Act.
- Refunded deposits will be mailed seven to fourteen days after rental.
- Renters must have permission to place any decorations on the walls and shall remove all decorations and items brought into the facility and dispose all trash in appropriate receptacles.
- Misrepresentation of rental or event is grounds for terminating without refund.
- Renter is responsible for and agrees to pay the expense of all City of Winter Haven off-duty uniformed law enforcement officers for events involving alcohol. Any event with a significant amount of guests are subject to procure City of Winter Haven of-duty uniformed law enforcement officer.
- Additional policies may be required upon further review by the City.
- All facility guidelines vary site to site, for inquiry about a certain facility contact their office phone number.
